










# **Timeline:** Remote Jobs and Economic Development Program

Outlining the transition from the Community Development Program (CDP) to the Remote Jobs and Economic Development Program (RJED) and a new remote employment service

RJED will initially create 3000 jobs over the next 3 years and will include a fund for capital and equipment to support employment.

CDP will continue as we develop a new remote employment service.

- August: Hosted remote employment roundtable
   2023
- Feb June: Consulted with remote communities
- December: Consulted with key stakeholders
- Began job trials: CDP Trial (November 2022),
   Ngaanyatjarra Lands Trial (July 2023) and
   New Jobs Program Trial (September 2023)

- Job seekers (who are able to work) move from income support to jobs.
- Economic development and jobs are supported across all levels of government.
- CDP contracts continue to June 2025.
- New remote employment services commence to support job seekers.
